The National Capital District Provincial Health Authority's Chief Executive Officer Dr. Robin Oge has officially presented the Clinical Services Plan of the New Provincial Specialist Hospital to the Governor for National Capital District Hon. Powes Parkop and the District Development Authorities of NCD. The proposed hospital is to be built at Tete in Port Moresby North West district. The clinical service plan covers all necessary clinical services and support services that will be provided at the new hospital. The Hon. Governor Powes Parkop has approved the Clinical Services Plan for the proposed level 5 Provincial Specialist hospital for NCD. He further emphasized that all future plans for the construction and expansion of other Health Facilities in the National Capital District have to be properly planned to meet the standards.

The Chairman for NCD Provincial Health Authority Mr. Daniel Waswas said that the Health Service plan will help fulfill the vision of National Capital District Commission to deliver effective health Services in the NCD. Mr. Waswas has acknowledged the support from the Governor Hon. Powes Parkop andDistrict Development Authorities of NCD.

The CEO for NCD PHA Dr. Robin Oge said the proposed State of the art level 5 Provincial Specialist Hospital as presented in the Clinical Service Plan will cater for Secondary and Tertiary care services. Dr. Oge said that the hospital will serve as a crucial referral hub by receiving patients from level 2,3 and 4 facilities within NCD, Central Province and Gulf Province. "The most complex and sub-specialty cases will be referred to Port Moresby General Hospital, allowing it to carry out its role as the National Tertiary Referral Hospital," said Dr. Oge. This will reduce the burden at PMGH because it is overwhelmed with patients seeking primary health care services. The hospital will also support all health facilities across NCD through outreach and serve as a vital training ground for future health professionals.

The boards and management of NCD Provincial Health Authority is working towards improving the health service delivery in the National Capital District through improving health facility infrastructure and collaboration with National Capital District Commission and the three District Development Authority of Port Moresby.

OFFICIAL LAUNCHING OF THE STAFF TRANSIT HOUSE & STAND BY GENERATOR AT 6-MILE POLY CLINIC



The National Capital District Provincial Health Authority's (NCDPHA) management has officially launched the staff Transit House and a 24 hours stand-by Generator at Six Mile Poly Clinic. The launching marks the contributing effort and commitment of the NCDPHA's Management, National Capital District Commission (NCDC) and Moresby North East District Development Authority (DDA's) to provide better health care in National Capital District and Moresby North East Electorate.

The District Development Authority of Moresby North East Chief Executive Officer Mr. Davis Kia said the Effective Health Service delivery in the district and throughout Port Moresby is vital. "The Member for North East Hon. John Kaupa is very vocal in providing better health services in his district and has plans to assist all existing clinics in his electorate," said Mr. Kia. He further emphasized that the Moresby North East DDA's will continue to work with the Management of NCD PHA to provide better health services to the people.

The Deputy Director for Medical Services at Port Moresby General Hospital Dr. Henao Asa said that the Emergency Department at PMGH now focuses on the patient who really needs their services as a result of category 3 services being moved to 6-mile clinics. "In the past, approximately 80 percent of the patients under category 3 services are seen at the Emergency Department at PMGH but today is decreases to 40 percent when 6- mile started operating as a 24-hour clinic," said Dr. Asa.

The Chief Executive Officer for NCD Provincial Health Authority Dr. Robin Oge said that the Management are now focusing on developing Six Mile Poly Clinic to be fully functional as a 24-hour clinic to assist the Emergency Department at PMGH. "The launching of the Staff Transit House and the Standby Generator indicates the commitment of NCDPHA's management to provide better health services to the people of Moresby North East and National Capital District," said Dr. Oge. He further emphasized that the Boards and management are working towards improving the health indicator of NCD.

The NCD Provincial Health Authority,
City Pharmacy Limited and the
National Department of Health has
launched the Media Campaign on
Maternal and Neonatal Tetanus
Elimination campaign in the National
Capital District and throughout
Papua New Guinea.

The Curative Health Director Dr. Michael Dokup said that through the Public Private Partnership Initiative, Tetanus Elimination in Port Moresby and PNG is possible. He acknowledges the City Pharmacy Limited for its partnership with key partners in the campaign against Tetanus Elimination Campaign.

The Acting Executive Manager for Population Health and Health Communities Dr. Lutty Amos from the National Department of Health said that Tetanus is a disease that infects the mothers and young girls through injuries and it is only preventable through Tetanus Vaccine. "Papua New Guinea is the only country in the Pacific with Tetanus," said Dr. Amos. With collaborative effort, it is possible to completely eliminate Tetanus in PNG.

The Head of Pharmacy Mr. Pradeep Panda said that City Pharmacy Limited did well through its partnership with NCDPHA's Clinic at Badilli. "It is possible to achieve our goal through collaborative effort in this campaign, "said Mr. Panda.

Dr. Dokup said that the partnership with CPL will be extended to other CPL sites within Port Moresby during this MNTE campaign and the upcoming Polio Immunization Campaign. "I strongly encourage all young girls and women between the ages of 15-44 years, including pregnant and breast-feeding women to visit their nearest health facility and mobile teams to receive the free tetanus immunization to protect themselves against tetanus disease," said Dr. Dokup.
